



Pickup & Return of Library Books

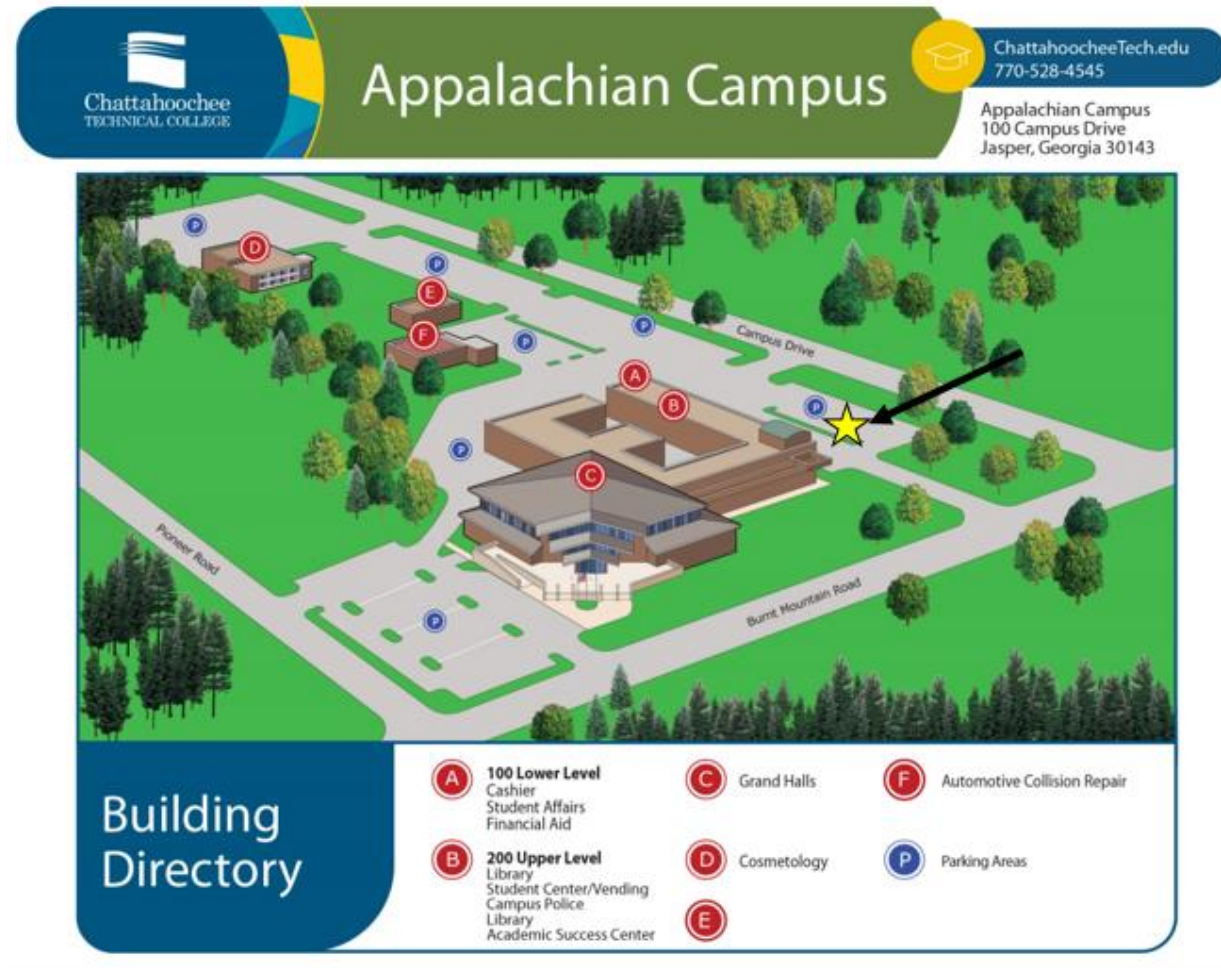
1. Please wear a mask and do not come to campus if you are sick

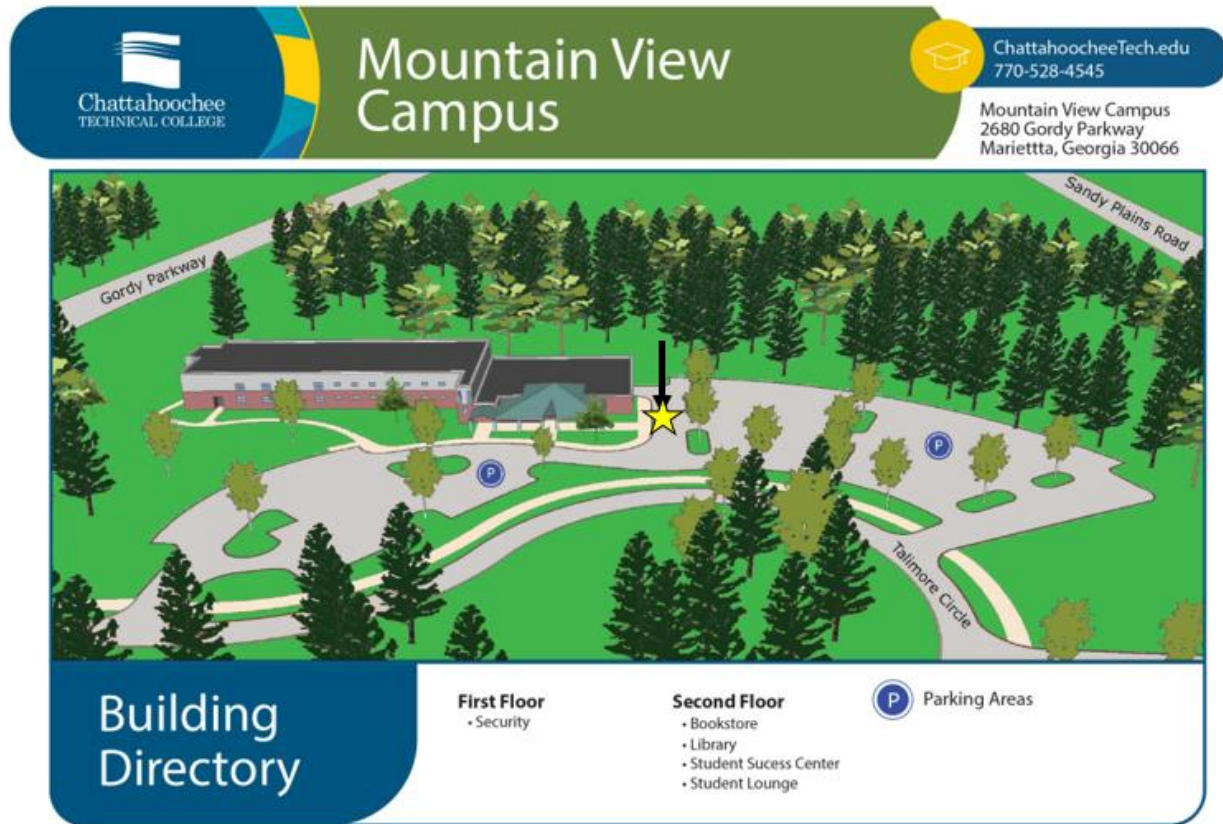

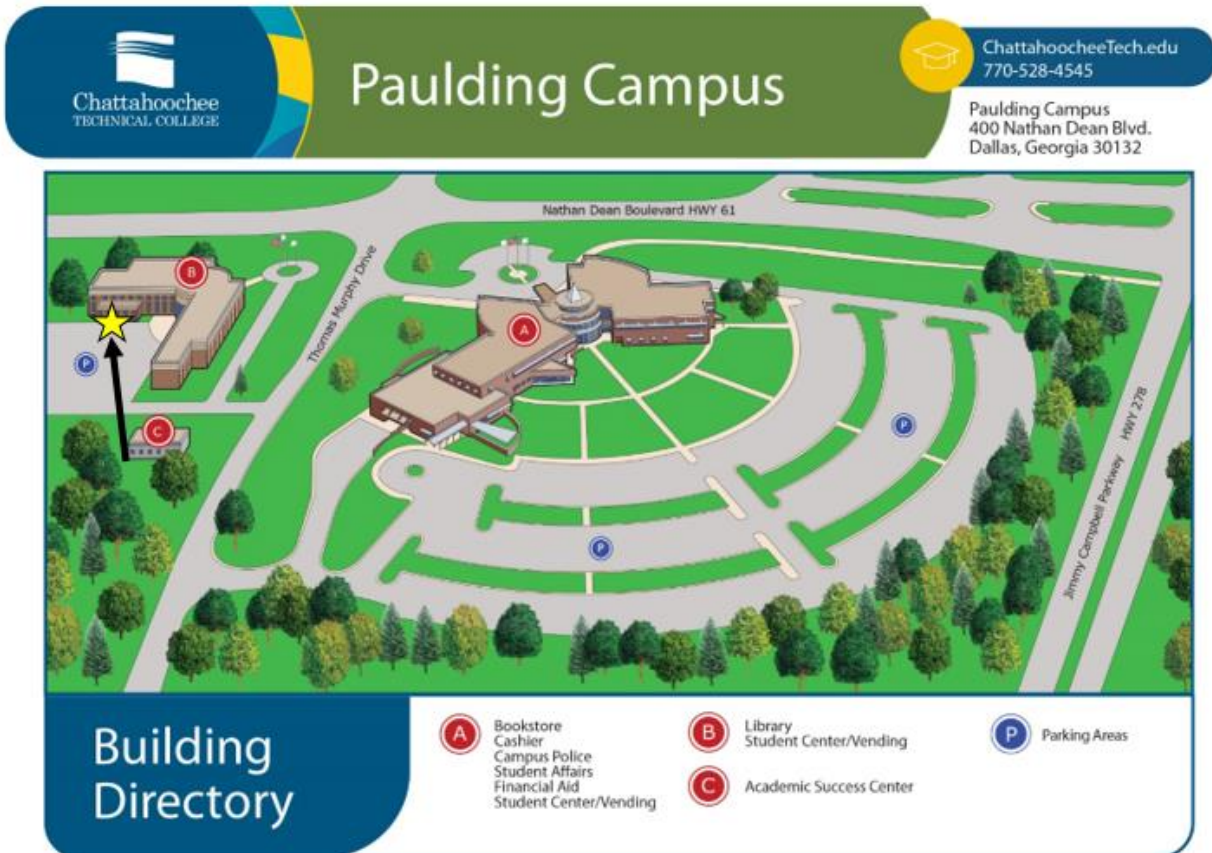
